1. All answers or information requested must be typed.
2. Type the essay, in 500 words or less, on the Essay Page of the application or attach a separate sheet.
3. Submit one letter of recommendation from a current or former teacher, or a school official who is familiar with your academic accomplishments and personal integrity.
4. Applicants enrolled in college or technical school may submit a transcript in lieu of test scores, class rank and GPA.
5. Application must be signed and returned to the credit union.
6. Electronic applications will be provided upon request however; no electronic return of applications will be accepted.

All applications must be received no later than close of business **March 19, 2010**. **All supporting documents and attachments MUST accompany the completed application.** Transcripts may be requested later.

### ADDITIONAL INFORMATION

- Only the recipients of the awards will be notified in April 2010. We regret that we will be unable to notify all applicants.
- The selection committee reviews all the information supplied in the application. Test scores, G.P.A., school and other activities serve as a guideline with more importance allocated towards reviewing the essay portion of the application and the letter of recommendation.

- Transcripts and other additional information may be requested later. They need not be included with the application.

## **FIRST FINANCIAL CREDIT UNION SCHOLARSHIP PROGRAM**

### **PURPOSE OF THE SCHOLARSHIP**

The First Financial Credit Union scholarship program was organized for the purpose of supporting graduating seniors, college undergraduates and technical school students in advancing their education. Scholarships will be given to individuals who have demonstrated academic potential during their high school education. The First Financial Credit Union, by investing in individuals and their futures, invests in the future of the nation and its number one resource, people. Financial need is not a consideration in the selection process. Everyone who meets the eligibility requirements has an opportunity to receive one of the scholarships to be awarded.

### **ELIGIBILITY**

To be eligible to apply for a First Financial Credit Union scholarship, a student must:

- be a member in good standing at the First Financial Credit Union.
- graduate from a public or private secondary school during the 09-10 school year or be enrolled as a full time student in an accredited technical school, college or university.
- have been enrolled, accepted or anticipates being accepted to a four-year academic institution or accredited technical school.
- be a United States citizen or permanent resident.
- have a GPA of at least 2.00 at the time of applying and complete either the S.A.T. or A.C.T. test.
- include a letter of recommendation from a current or former teacher, or a school official.
- complete the application and personally write the essay.
- not be enrolled in graduate programs.

If you meet all of the above requirements, you are encouraged to participate in the First Financial Credit Union scholarship program by submitting the application materials. Each individual receiving an award will be personally notified by mail.

### **AWARDS**

\$1,000 scholarship paid directly to the institution of choice upon award notification and acceptance. The scholarship is non-renewable. Students receiving awards are encouraged to apply annually.

Two scholarships will be awarded in April 2010.
